Pseudonym

A pseudonym as defined by the Copyright Act means your alias or an artist's brand. State your pseudonym only if you wish to protect your identity in relation to the works notified under the pseudonym. You can also continue to notify your works under your real name. The OSA shall register the individual works either under your pseudonym or real name, whichever is stated in your application. Therefore it is always necessary to notify a work either under a pseudonym or a real name.

Other name versions

If you wish to register your works under a different name than your real name or pseudonym (e.g. „Richard Smith” – „Rich Smith” – „Richie Smith”).
