

Average room occupancy rate of the accommodation establishment is applied linearly in the calculation of royalty. The occupancy rate is applied up to a maximum of 30% (i.e. the maximum discount is 70%). To calculate the occupancy rate, the average occupancy rate in the period for which the license is granted shall be used. Any period for which the establishment is not operational shall not be taken into consideration when calculating the occupancy rate.*

* In view of the ongoing negotiations with public users on the future form of the tariff, collective management organizations have decided to disapply the lower limit of occupancy rate when calculating royalty for public performances in the rooms of accommodation establishments, temporarily for the year 2022 for the duration of the negotiations on the new method for determination of the minimum royalty. Operators shall apply for the reduction and, with respect to specific months of 2022, credibly document the occupancy rate for the months when their establishment was open.

IV. Tariff for spa, health and rehabilitation facilities



This tariff sets out only the royalties of OSA and DILIA. Rates of other collective management organizations are specified at www.intergram.cz. In this segment, OSA does not grant licenses for use on behalf of other collective management organizations (INTERGRAM, OAZA, OOA-S).

The occupancy rate is applied up to a maximum of 30% (i.e. the maximum discount is 70%). To calculate the occupancy rate, the average occupancy rate in the period for which the license is granted shall be used. Any period for which the establishment is not operational shall not be taken into consideration when calculating the occupancy rate. Unless the rate is agreed otherwise and unless the works are made available to patients in the provision of health services, the royalty shall be determined according to Part III. of this tariff.*

* In view of the ongoing negotiations with public users on the future form of the tariff, collective management organizations have decided to disapply the lower limit of occupancy rate when calculating royalty for public performances in the rooms of accommodation establishments, temporarily for the year 2022 for the duration of the negotiations on the new method for determination of the minimum royalty. - 1. This tariff sets outs the proposed rates of royalties or the method of determination of royalties for the granting of a license to use musical works via audio apparatus (e.g. radio broadcast receivers, CD players, music towers) in the tariff also referred to as "background music", or audiovisual apparatus (e.g. televisions, DVD players, computers) in the tariff also referred to as "TV apparatus" or "TV", in cases where the performance of the works does not have the character of a program, is not intended to dance to and where the works are not performed by performers (DJ). Performance of works is only a supplement to other services and, therefore, the admission fee, if any, is not directly related to the performance of musical works.
- 2. A musical work according to this tariff shall mean any musical work and any verbal work used in connection with a musical work from the OSA repertoire.
- 3. The rates of royalties are stated exclusive of VAT which shall be added at the standard rate according to general legislation.
- 4. The minimum royalty is considered the minimum value of the OSA repertoire regardless of the scope of use of the OSA repertoire.
- 5. Cases not regulated by this or any other tariff shall be handled by agreement.
- 6. The rates of royalties are set out for each commenced calendar month of use unless stated otherwise.
- 7. This tariff shall replace any previous tariffs which set the rates of royalties for the granting of a license to use the works as specified in this tariff.
- 8. This tariff shall come into force and take effect on 1 January 2022.
- 9. Tariff A applies where the operator requests a draft license agreement without any assistance from an OSA employee present at the operator's establishment or without any link to an inspection carried out at the operator's establishment, and provided that OSA has no overdue claims against the operator at the time of issuing the draft license agreement. Tariff B applies to other cases. Where tariff B is not directly indicated herein, it shall be calculated as 1.15 times tariff A.
